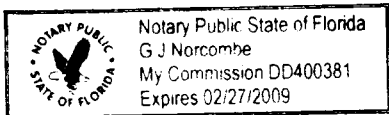

**AMENDMENT TO THE
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR ADDISON RESERVE**

Note: New language is underlined; language being deleted is shown in **struck through** type.

Subsection (A) of Section 9.3 of the Declaration of Covenants, Conditions and Restrictions for Addison Reserve shall be amended as follows:

9.3 Leasing. An owner may lease his Living Unit without prior Association approval, subject to the following restrictions:

(A) The lease must be written, and a fully executed copy must be provided to the Association not less than thirty (30) ~~three (3)~~ days before the beginning of the lease term, together with such other information about the tenants as the Board may reasonably require.
