## AMENDMENT TO DECLARATION

Section 11.12 of the Declaration of Covenants, Conditions and Restrictions for Brittany Place shall be amended as follows:

11.12 Water supply; wells; water rights. Each Villa shall be equipped with dual water lines, one of which shall be designated to utilize non potable water. All irrigation systems must be connected to the non potable water line and all outside spigots must be connected to the potable water line.
