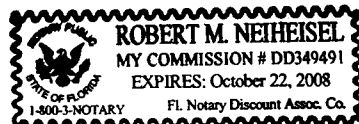

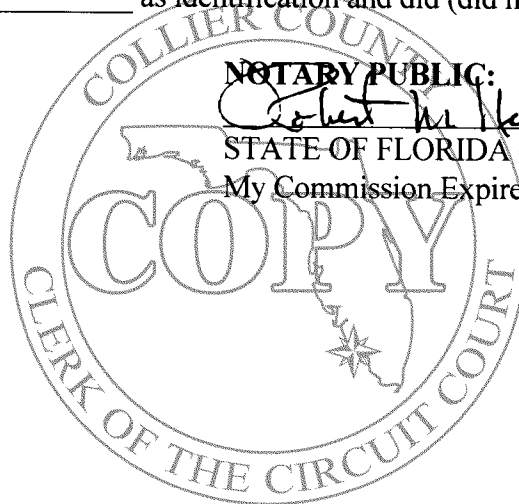

PROPOSED DOCUMENT CHANGES TO DECLARATION  
SECTION 13.3

**NOTE:** New language is underlined; language being deleted is shown in ~~struck through~~-type.

- 13.3 Term of Leases and Frequency of Leasing.** No unit may be leased for a period of less than thirty (30) days. No more than four (4) such leases will be approved in any given year. No lease may be for a period of more than ~~one (1) year~~ six (6) months, and no option for the lessee to extend or renew the lease for any additional period shall be permitted. However, the Board may, in its discretion, approve the same lease from ~~year to year~~ one period to the next. No subleasing or assignment of lease rights by the lessee is allowed.
